
NDHIN Monthly Q & A January 21, 2021

Topic focus: How has NDHIN helped with the COVID pandemic?

The monthly Q & A meetings provide a forum for sharing NDHIN updates and information. It also allows users an opportunity to ask questions. The team will present a specific topic each month, but welcome questions regarding any topic. Questions and Answers from the January session are below:

Q My patient reports a recent COVID-19 test from another facility. Where can I find/verify that information in NDHIN?

A Upon accessing a patient's record, the report can be found in the Laboratory reports section. The results are reported in real time, there may be minimal reporting delays for quality reporting purposes. In general, all results should be reported in NDHIN. On rare occasions, it may have been processed at a lab that does not report to



 ${\sf Q}$ What other COVID-related work has been done?

A ND Department of Health staff can use NDHIN to assist with Contact Tracing. NDHIN can be used to verify testing as shown above, and to assist with verifying demographics to contact those who have tested positive for COVID or have been exposed. Some facilities have set up Electronic Test Orders and results (ETOR). This enables laboratories and health care providers to directly exchange standardized test orders and results across different facilities and electronic information systems using agreed upon standards. NDHIN also provides a venue for electronic lab reporting for reportable conditions to State Department of Health.
